Mrs. Denise Verreault, 48, obtained a Bachelor of Education from Université du Québec à Rimouski, obtained an Honorary Doctorate of Management from the University of Ottawa, was awarded Knight of the National Order of Quebec and Member of the Order of Canada. Since 1982, she is Chief Executive Officer of Groupe Maritime Verreault inc. She holds several positions : President of Germanischer Lloyd's Canadian Comitee, Director of the Corporation de soutien au développement technologique des PME, Member of Lloyds Register's Canadian Comitee, Member of the advisory comitee of Construction Navale et Maritime Industrielle (CCNMI) and Director of the Ombudsman for Banking Services and Investments (OBSI). Previously, Mrs. Verreault served as member of various boards and comitees including the board of directors of the Université du Québec à Rimouski, the board of directors of Desjardins Insurance for Life, the board of directors of the Chamber of Commerce of Quebec, the board of directors and Chairman of the audit comitee of the Société Québécoise de Développement de la Main-d'œuvre (SQDM), the board of directors of the Caisse de Dépôt et de Placement du Québec, the board of directors of Air Nova / Air Alliance, the Minister Advisory Council on Oceans (MACO), the board of directors and Chairman of the audit comitee of the St. Lawrence Seaway Management Corporation as a representative of the Federal Government, the board of directors and Chairman of conduct comitee of Capital Régional et Coopératif Desjardins and the board of directors of the Hôpital de l'Enfant Jésus' Foundation. Mrs. Verreault received several awards in recognition of her achievements: Quebec's Businesswoman of the Year in 1991, 1995, 1999 and 2005 as well as Gala des 500's Job Creation Award for the "Woman Entrepreneur" category in 1998 and Entrepreneur 2000's Achievement Laureate in October 2000.

Mr. Bernard Mercier, Chairman of Mercator's board of directors, said: "We are pleased to welcome Mrs. Verreault to Mercator's board of directors. Her impressive track record combined with the diversity of her experience will be precious assets in Mercator's progression".

Along with this appointment, Mercator has issued 100 000 stock options to purchase Mercator's common shares at a price of \$0.25 per share to Mrs. Verreault. These options were issued as of July 26, 2007 and expire in 5 years.
